### DUES and BUDGET INFORMATION

To date we have a surplus for 2023, but there are still potential expense that have to be paid - such as landscaping, pond pump winterization, electricity, lawncare and snow removal

Dues for 2024 will be \$620. It will be split in 2 installments: \$310 due March 1 and \$310 due June 1

#### 2024 Budget Notes -

- Dues were voted to be \$650, but due to quotes received and change in vendors, we were able to reduce to \$620
- Increased collection expense in budget based on 2023 actuals (collections dues are reimbursed from the home owner)
- Accounting fees are increasing due to additional work for allowing payments due in 2 installments
- Pre-emergent and mulching increased from vendor
- Trash removal is for the trash at the pool
- Pool repairs are for a new water heater and some additional maintenance needed in the facilities
- Pool security increase to add internet to the system to allow for enhanced security
- Pool furniture is a new item due to we had to dispose of a few chairs because they broke in 2022
